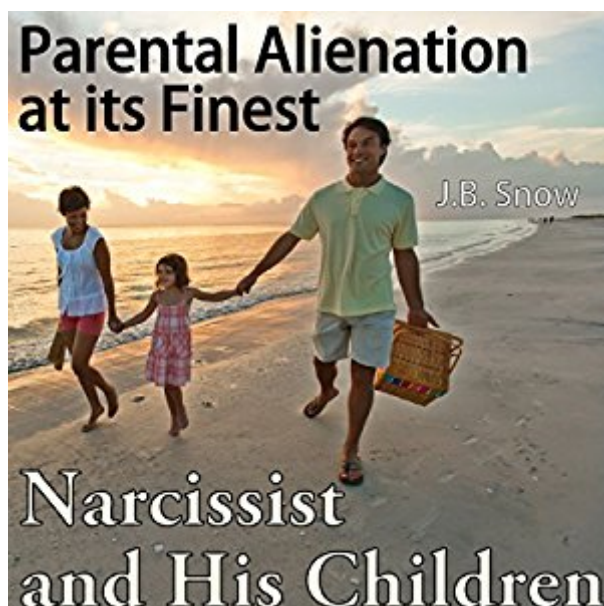

This short read has important and helpful information about narcissistic abuse and parental alienation in simple, easy-to-understand terms. It's a great tool for parents and professionals alike. However, there isn't much information on the solutions for dealing with a narcissistic partner in a divorce or custody battle. The authors assume that the court system appreciates and sides with

the mature adult/parent, when that is not always the case. Only a small percentage of narcissists are diagnosed (1% of the population) because of the very nature of the disorder. Narcissists don't think there's anything wrong with them and therefore, go undiagnosed unless they're forced by Law Enforcement and/or a Judge. But first, they have to warrant such an order, which rarely occurs because they know how to manipulate the system and most Judges don't know enough about abnormal psychology to know what to look for. It is imperative that any target of Parental Alienation document every offense, every incident, every comment or slight involving the narcissist, especially if there are children involved. Go to a qualified psychiatrist, experienced in child and adolescent psychology to have the children evaluated for PAS (in some states, you can have them involuntarily committed for 72 hours to be evaluated, but check your state laws). You can do very little until the court system is aware that there is documented evidence of abuse or a professional evaluation has been performed. The narcissist is afraid of being exposed and will do anything to prevent it, so watch your back!!
