

Synopsis

Over the last three decades, welfare policies have been informed by popular beliefs that welfare fraud is rampant. As a result, welfare policies have become more punitive and the boundaries between the welfare system and the criminal justice system have blurredŢâ \neg ⠕so much so that in some locales prosecution caseloads for welfare fraud exceed welfare caseloads. In reality, some recipients manipulate the welfare system for their own ends, others are gravely hurt by punitive policies, and still others fall somewhere in between.In Cheating Welfare, Kaaryn S. Gustafson endeavors to clear up these gray areas by providing insights into the history, social construction, and lived experience of welfare. She shows why cheating is all but inevitableŢâ \neg â •not because poor people are immoral, but because ordinary individuals navigating complex systems of rules are likely to become entangled despite their best efforts. Through an examination of the construction of the crime we know as welfare fraud, which she bases on in-depth interviews with welfare recipients in Northern California, Gustafson challenges readers to question their assumptions about welfare policies, welfare recipients, and crime control in the United States.

If you are poor in the United States of Amercia today you are a marked man or woman. The legal system is out to get you make no mistake you are considered a common criminal if you are poor in the United States in 2014. The legal system has set FOUR very effective traps to ensnare poor people. Trap One goes under the guise of Welfare Reform. Trap Two goes under the guise of The War On Drugs. Trap Three uses the stigma of prior eviction or income source to insure poor people's stay woefully sub-standard grossly expensive slumlord housing. Trap Four Criminalizes the actions that arrise out of living on the streets due to being Homeless. It is the exceedingly rare black

or brown minority person that is able to avoid all four traps. I was able to succeed BUT, I was a poor black guy on disability in a run down section 8 apartment. I did not have kids I couldn't afford. I wasn't a dope addict or drunk. I did not have a criminal record. I was intelligent, well mannered and well spoken. Most of all my household budget management skills were far above average. It did not hurt that I was content to live well within my limited means at the time. There are many great books that speak in detail about how Trap Two's War On Drugs targets mainly the poor for its unique form of slavery in prison and social banishment in prisons of poverty upon release. There are great books that speak to the issues of trap threes targeting of poor people by criminalizing homelessness. This book speaks effectively to the first trap that now makes collecting Welfare a maze of rules and regulations designed to confuse, punish and demean those who are forced to apply for the meager benefits provided. Welfare used to provide for those who live in abject poverty. Now Welfare is a tool used to subsidize huge corporations that make gigantic profits by paying most of its employees slave labor near minimum wages. I have no love for those who live to truly cheat the Welfare system. I think true welfare cheats should be bannished from all forms of public assistance for life.But this book Cheating Welfare is about far more than your standard welfare cheat criminals trying to get by illegally but using the systems.
