


The book was found

Synopsis

Dale Johnston was arrested, tried and convictedfor the dismemberment murders of his stepdaughter, Annette Cooper, and her fianc $\tilde{A}f\mathcal{E}$ \tilde{A} \hat{A} , Todd Schultz. He was sentenced to die in the electric chair. His conviction by a three-judge panel was later reversed by the Ohio Court of Appeals and that decision was subsequently upheld by Ohio's Supreme Court.
